



Emissions reduction targets

To achieve Net Zero, the business had adopted the following carbon reduction targets. We projected that carbon emissions would decrease to 14,420 tCO2e by 2027, a baseline reduction of 19%. However, we managed to achieve this target within a year in 2022. Our revised carbon reduction target for 2023 was then to see emissions decrease to 11,215 tCO₂e by 2027, giving a reduction of 37% against the 2021 baseline. We also managed to achieve this sooner with total 2023 emissions seeing a baseline reduction of 38%. Our revised carbon reduction target for 2024 was to see emissions decrease to 6,000 tCO₂e by 2028, giving a reduction of 66% against the 2021 baseline. By implementing additional carbon reduction measures, we are well on track to meet or exceed this target.


Carbon Reduction Initiatives Completed

The business in 2024 has been able to reduce its property footprint through better utilisation of the office spaces it occupies and utilisation of environmentally friendly company vehicles, whilst the building management have continued to focus on making offices more energy efficient. The business in 2024 has managed to achieve a further reduction in emissions of 17% when compared to the previous year and 49% when compared to the 2021 baseline.





























Carbon Reduction Projects


Whilst the Company does not produce any emissions or pollutants that come under the Integrated Pollution Prevention and Control Regulations, the company has identified areas of focus in order to minimise its impact on the environment. These include:

- Maximising the reuse, recycling and sustainable disposal of waste.
- Minimising unnecessary energy usage and waste and use more energy efficient lightbulbs.
- Purchasing consumables in an environmentally sustainable and fair manner.
- Allowing staff members to work from home so there are fewer people commuting to work, which in turn translates to fewer emissions.
- Work with suppliers who recognise and work to reduce the environmental impact of their products and services.
- Inform and train all employees of the companies' environmental objectives and how they can assist in meeting targets e.g. printing only when necessary.
